

# International Audiovisual Contest "Città di Garbagnate" 3<sup>rd</sup> edition - 2019

## Rules

### 1. Purpose

The contest promotes the culture of audiovisual, a particularly creative and complete photographic discipline.

The contest is open to worldwide authors whether they belong to a club / federation or not.

The term "author" means the person or group of people that produced the audiovisual or personally managed the production exploiting the contribution of others and who takes care of submitting it to the contest.

All sequences submitted will be examined by the official jury or if necessary by a pre-selection jury with at least one member of the official jury, depending on the amount of works received. The official jury will determine acceptances, the awards and any commendation or special award. The jury will judge the audiovisual and not the author.

### 2. Definition of audiovisual sequence

An audiovisual is a communication medium that blends pictures, sounds, spoken texts: **pictures are its key feature.**

Video inserts are allowed if strictly functional to the storyboard, though they cannot prevail over pictures.

The work must be harmoniously structured and must own a script and a communicative intent.

Subject is free and no genre distinction is applied during evaluation.

### 3. Characteristics of the sequences

**Each author may submit up to three sequences, each one no longer than 12 minutes.**

**Sequences that were already submitted to previous editions cannot be accepted.**

**Sequences done before 2016 cannot be accepted.**

**Sequences can be done through old slides turned into a digital work.**

Audiovisuals including spoken text must be submitted with the corresponding text (be it in: English, Italian or French).

The organization will take care of translating the text, so as to let foreign people understand it.

The organization will deny any responsibility for any mistranslation.

### 4. Registration fees

The jury will gather on the scheduled days. Screening sessions are open to public.

Members of the organization crew, members of the jury and their relatives are not allowed to take part in the contest.

If the screening time exceeds the forecast terms, the jury will view the audiovisuals in advance, in order to select the ones to be projected. The jury may ask for additional views of audiovisuals when debating the awards.

Each author must send:

1. the filled in registration form with handwritten signature (see last page)
2. receipt of payment
3. a passport size photo of the author (45mm x 35mm at 300 dpi) and **for each** submitted audiovisual:

- .mp4 / mov - Data compression H.264 – 1080p/25fps

#### The following items are not allowed:

- 1) sequences that need additional software or special settings
- 2) sequences that need equipment of the author
